DISCUSSION:

Assembly Bill 1826 amended the California Integrated Waste Management Act to add provisions requiring organic waste recycling for commercial accounts beginning April 1, 2016. In addition, it also requires local jurisdictions to adopt an Organic Waste Recycling Program. CR&R will give a presentation on their proposal for complying with the new requirements.
