**STAFF REPORT**

**RECOMMENDATION:**

Staff recommends that the Subcommittee receive the report and provide recommendation to the City Council regarding Waste Management's green waste and recycling services.

**DISCUSSION:**

The City has franchise agreements with two waste haulers. CR&R provides services to the West side of the I-15 and Waste Management provides services to the East side of the I-15. Currently, CR&R provides weekly trash, recycling and green waste pickup. Waste Management provides weekly trash pick-up and bi-weekly recycling. Green Waste pickup is provided to certain designated service areas. Areas such as The Farm do not have the option for a green waste bin. It is staff's recommendation that the subcommittee discuss the idea of having "like" services in both service areas, discuss green waste bin options for areas not currently being serviced and provide a timeline for the transition of suggested changes.
