**SUBJECT:** Waste Management Green Waste and Recycling Services Update

**STAFF REPORT**

**RECOMMENDATION:**

Staff recommends that the Subcommittee receive the updated report from Waste Management and provide recommendation to the City Council regarding green waste and recycling services for residents on the east side of the Interstate 15 Freeway.

**DISCUSSION:**

At the May 13<sup>th</sup>, 2016 Franchise Subcommittee Meeting, Waste Management presented a report to the subcommittee regarding their green waste and recycling services. Currently, CR&R provides weekly trash, recycling and green waste pickup to Wildomar residents on the west side of the I-15. Waste Management provides weekly trash pick-up and bi-weekly recycling to residents east of the I-15. Waste Management currently provides Green Waste pickup to certain designated service areas and areas such as The Farm do not have the option for this service. .

In response to the Subcommittees recommendation from the previous meeting to provide “like” services on both sides of the I-15, Waste Management researched the cost and provided a timeline to provide “like” services on the east side of the I-15. The proposed cost for weekly recycling and green waste for all residential customers is \$25.82 per month, which matches CR&R’s fees for “like” services. This would be a \$2.07 increase from the current cost for service. It is staff’s recommendation that the subcommittee receive the update and provide recommendation to the City Council.

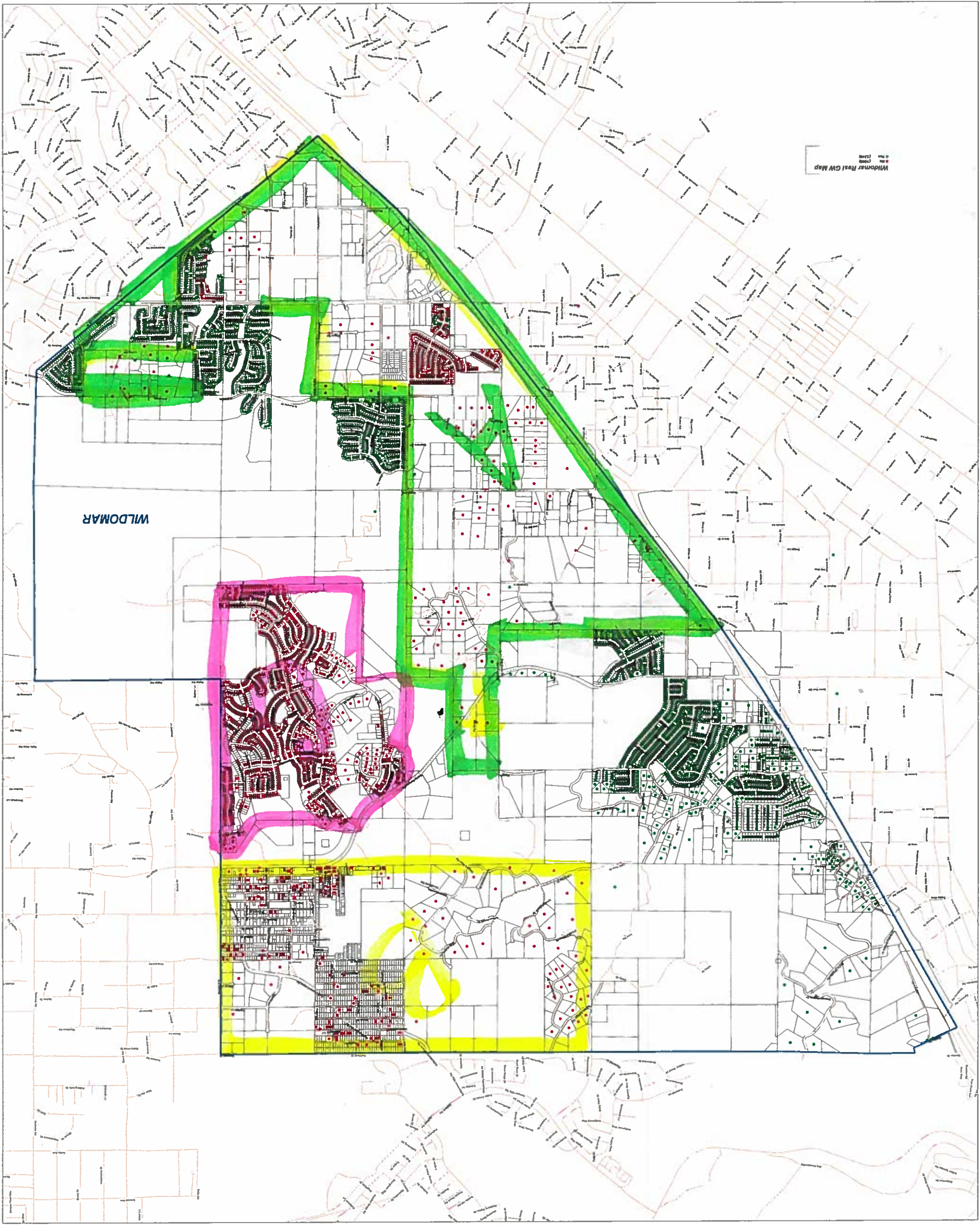
